- The committee shall not recommend quantum or mode of punishment as Dean is the Disciplinary authority who will decide on merit of the enquiry report.
- The AO of the college shall arrange for the enquiry and assist to preparation of the enquiry report in her capacity as the Head of the Dean's Office.

The tenure of the committee members shall be two years and upon relief of any member, the post will be substituted with an eligible faculty.
